At Chicago School of Golf, we strive to help our students improve their golf game at a pace that makes it enjoyable and effective. We believe in working with students in various ways, including private lessons, group lessons, and playing lessons on the course. Using these three different approaches, we help the players develop a feel for the game that is personal to them. This Handbook will outline all the rules and policies we use to make our players enjoy the game and practice effectively.

## RULES

---

**Tardiness** – At Chicago School of Golf, we ask that all our students arrive for their lesson on time. If a student consistently shows up late to a lesson, the instructor may have to ask the student to find a different time or pick a different lesson format. This ensures that the time in each lesson is used effectively and worth the amount of resources put into the lesson. Please do not expect the instructors to wait or teach beyond the designated time for a class if you are late.

**Student Etiquette** – Students are expected to behave and act accordingly on the golf course. This means that all students will dress in golf attire for every lesson (See Golf Attire Section)

and hold themselves in a way that reflects well on Chicago School of Golf. Cellphones or other devices are prohibited during a lesson. It is up to the instructor to cancel a lesson based on a student's behavior without warning. There will be no refund if the lesson is canceled or the student is dismissed.

**Student Expectations** - At Chicago School of Golf, we take improving all student's games seriously. We expect students to work hard for the time we are together. We ask everyone to listen to the coaches as this makes the learning environment more enjoyable for all participants. If a student responds to a task with the word "NO," the coach will ask them not to participate until they complete the challenge. Each request by the coach referred to here will be within the realm of golf and at the student's level. An example task would be to complete a putting drill. As coaches, our job is to show students they can accomplish things even when they think it's impossible. We can only help them achieve this level of success if respect and effort are given.

**Parent Etiquette** – We ask parents to be involved with their junior golfers outside the lesson. Parents need to push their junior golfers to practice and enjoy the game. However, we ask that for distraction purposes, parents **do not attend or observe the classes**. We are a drop-off and pick-up-only golf school. Parents may attend the last five minutes of a lesson to hear what their child is working on, so they are informed on how the student should practice. We also encourage parents to call the coach to discuss their child's game. During every class you will receive a swing video with notes and a progress report to inform you what your child is working on.

**Golf Attire** – Students are expected to wear golf attire at all times, especially while practicing on the golf course. This dress code may be changed for indoor studio practices at the instructor's discretion. Below is a list of the attire accepted while practicing on the course.

**Men** – Polo or collared shirts with dress pants or shorts, including a belt.

**Women** – Polo or collared shirts with a golf skirt/shorts, dress pants, or sports pants/leggings.

**Summer Hours & School Hours** – Our schedule changes twice a year. Once in early June for "Summer hours" and again in early Fall for "School hours." We will include this in our newsletter a minimum of 30 days prior to the times changing for the seasons.

## **BILLING POLICIES**

---

### **Billing Details:**

- We only accept credit cards.
- Your payment starts two days before your first.
- Tee time fees are additional costs. they will be charged to your credit card the day after your lesson. Sydney Marovitz's 9-hole fee is \$35, and all other course fees are \$25.
- The billing takes into account all holidays off (listed below).

- If your class falls on a scheduled holiday there are no makeups.

## CANCELLATION & MAKEUP POLICY

---

### Make-up Details:

We allow makeups for missed classes if you follow the rules outlined below.

- We do not “pause” membership for any reason whatsoever.
- If you can not attend your regular scheduled class. A **24-hour notification** is needed before the start of your class to receive a make-up.
- You can make up by joining another class at your level.
- You must make up the class within four weeks of the missed class.
- Make-up classes can not be transferred to anyone.
- We **do not** allow make-ups after you stop paying for classes.
- We **do not** offer refunds for make-up or missed classes.
- There are no make-ups or refunds if your class falls on a Holiday. The holiday schedule is on the next page.
- The student must contact the Chicago School of Golf to schedule their make-up before the four-week deadline.

### Cancellation Details:

- Before canceling your subscription, you must complete the minimum requirement “Initial period” of 3 or 6 months. If not canceled the billing continues each month.
- You can cancel your subscription after the 3 or 6-month time period “Initial Period” is met. See the next bullet point!
- To cancel after your initial period, you must email [info@chicagoschoolofgolf.com](mailto:info@chicagoschoolofgolf.com).
- You must email the Chicago School of Golfs office 30 days prior to canceling payments.

## ON COURSE LESSON POLICY

---

When we are scheduled for 9 or 18 holes on the course with a coach, please arrive 30 minutes before the start of the lesson to warm up. You can chip, putt, or purchase a small bucket of balls for the range. All courses want the group on the first hole tee box 10 minutes before their tee time.

- The coach will always meet you on the putting green.
- We can not wait if you are late because we risk losing our tee time.

- You need golf clubs, tees, balls, and a water bottle when playing.
- We will walk the course most of the time. You can bring your own pull cart or rent one from the golf course.
- Chicago School of Golf is fortunate to have partnerships with these courses. Taking care of the course and keeping pace of play is very important to maintaining these relationships. Sometimes, this means we must pick up a ball if we are slow.
- All tee time fees will be billed to you the day after your lesson.
